The DeForest Windsor Fire & EMS Fire Protection Board has authorized the DeForest Windsor Fire and EMS Department to bill for services based on the following schedule:

EMS Services

- BLS/ALS Resident-\$1550
- BLS/ALS Non -Resident-\$1750
- ALS 2 Resident-\$1650
- ALS 2 Non-Resident-\$1850
- BLS On-Scene Care Resident-\$400
- BLS On-Scene Care Non-Resident-\$450
- ALS On-Scene Care Resident-\$800
- ALS On-Scene Care Non-Resident-\$900
- Mileage Resident-\$21
- Mileage Non-Resident-\$22

Fire Services

- Vehicle Extrication-\$500
- Vehicle Fire-\$500
- Working Structure Fire (one or two family residential)-\$500 plus expenses
- Working Structure Fire (commercial)-\$1000 plus expenses
- Outside Fire (as a result from unauthorized burn or uncontrolled burn)-\$500
- Nuisance Fire Alarms (more than 3 in a 12-month period) \$150 per alarm after 3
- Fuel Spills \$300 plus expenses

Expenses and Consumable Supplies

- Responding personal-\$15 an hour per person
- Class A Foam-\$10 per gallon
- Class B Foam/AFFF -\$100 per gallon/plus clean-up costs
- Oil Dry 40#<-\$20 a bag
- Sand-\$10 a ton
- Heavy Equipment-\$100 an hour

Permits

- New alarm systems or modifications affecting more than 4 devices-\$50+\$.02/sq.ft
- Alarm systems modifications up to 4 devices added or changed-\$100

Suppression Systems

- New Sprinkler system or system expansion with more than 20 heads added-\$50+\$.02/sq.ft
- New sprinkler system or system modification with less than 20 head-\$100
- Suppression systems (kitchen hood, clean agent.etc)-\$250

Miscellaneous Inspection Fees

- First System Inspection-Included
- First System Re-Inspections-Included
- Subsequent System Reinspection-\$100 each
- Late Application Fee (system installation begins prior to obtaining DWFD permit)-\$100 +100% of standard permit fee.
- Expedited Inspection Fee (Less than three business days' notice or outside of 9am-3pm Monday through Friday)-\$100 per inspection.
- Fire Code Compliance requiring more than two (2) inspections-\$200 per inspection after the first two (2)

Education Fees

- Fire Extinguisher Training (Minimum 10 people)-\$15 a head
- Event Appearance (excludes non-profit organizations) Charge per hour per apparatus per hour-\$100
- Heart Saver Adult/Child/Infant CPR AED-\$65
- Heart Saver Adult/Child/Infant CPR AED +First Aid-\$75
- Adult or Child First Aid-\$35
- Healthcare Provider Basic Life Support \$75
- Replacement Card-\$20
